#### **CURRENT RESEARCH**

My current research centers on the "Politics of Recognition" in Latin America. I examine how Latin America high courts are defining prior consultation (the right of indigenous peoples to participate in decision making that affects their communities). The judiciary has the potential to establish a standard that protects the rights of indigenous peoples, but the pattern of judicial decisions in the region demonstrates that this will not be a straight-forward path.
